Annual Audit:

Frank DeFroda, the Auditor from Whisman, Giordano, reviewed the results of the Annual Audit. The Firm was engaged to audit the financial statements for the City of Cape May Housing Authority as of September 30, 2019. The audit includes examining a on a test basis the transactions of the Authority throughout the year. The review includes various cash receipts, invoices and cash disbursement, procurement procedures and that all invoices are approved by the appropriate management personnel.

Overall, the opinion is that it is a clean audit. There were no significant findings or recommendations made from the audit process.

The financial statements include the GASB75 Pension liability. The balance sheet indicates total assets of 1.1M, the liabilities were approximately 1M, net assets was a minus \$700,000.00. This has to do with the post-retirement plan. This year the post-retirement liability is estimated to be \$600,000.00.

The revenues for the year was an increase of approximately \$54,000.00, total revenue was \$854,000.00, total expenses were \$856,000.00, resulting in a small loss of approximately \$2,000.00.

The audit reflects an additional disclosure concerning the non-profit to show some Board Members and some employees are associated with the entity.

There being no questions Mr. DeFroda was excused from the meeting.

EPA BRIEFING:

Keith Glenn, EPA Representative, presented a brief summary of information of their operational plan for the Osborne Court Apartment property regarding the assessment that will be conducted:

- EPA distributed the fact sheet to all of the residents
- Completed sample collections on August 10, 2020
- Collected a total of 150 samples from Osborne Court from 5 locations down 2-feet, (0-1", 1-6", 6-12", 12-18" and 24").
- Samples were also collected inside the crawl spaces on Osborne Court
- Approximately 2 months before the results of the samples come in

ACCOUNTANT'S REPORT:

The Board reviewed the tenth-months ending Income & Expense Statement. The bottom line for the eight-months ending July 31, 2020 was \$34,020 profit.

The E.D. reported that the deadline for submitting required documentation for RAD has been extended until December 2020 because of the environmental issues.

ENVIRONMENTAL:

The matter was addressed in Executive Session. The Authority will be advertising for a Consultant.

NON-PROFIT:

Chairperson Dr. Keith Lafferty reported that the annual fundraiser has not yet been scheduled.

CMC has sponsored a number of activities for the summer including Tennis, Sailing and Tutoring Programs.

Additionally, Cape May Cares has partnered with Stockton University who will be providing an Intern to act as a Social Worker for the Tenants.

Art lessons will begin on Saturdays.

BUDGET:

Ms. Avena reviewed the proposed 2020-2021 CMHA Budget. Total projected operating receipts is \$839,720; total projected operating expenses is \$762,450. The E.D. also reported that the Authority will be hiring a Part Time Maintenance Worker.

CAPITAL FUND:

HUD has announced that the Capital Funding for the year 2021 will be in the amount of \$160,545.00.

PROVIDER RFPs:

The Authority has advertised for the three providers, Legal, Accounting and Auditor whose contracts expire as of September 30, 2020.

ACCOUNTS RECEIVABLE DECREED UNCOLLECTIBLE:

The Authority completed the annual write off of uncollectible Tenant Accounts in the amount of \$3,707.41.

VECTOR SECURITY CAMERAS:

The Authority received a quote from Vector Security to replace the broken video cameras on Broad Street Court. The installation price for the system including parts, labor and training time is \$13,925.00 plus the Vector Comprehensive Service program of \$120.00 per month.

1. The Authority is exploring the possibility of purchasing a generator.
