Ms. Hackenberg reported the following:

# **ENERGY SAVINGS:**

The energy savings for the last period was \$928.50 or 11.53%--to be updated

#### **COMMISSIONER:**

Chairperson Dr. Keith Lafferty confirmed that two Commissioners need to complete their training before the deadline date, one of which is March 17, 2020. The E.D. confirmed that arrangements are being made to provide private classes through Rutgers for these Commissioners.

Attorney Gabage again reiterated that the Statute provides that Commissioners must complete the training within eighteen months of their appointment date and there is no grace period on the eighteen months. If the training is not completed, then the Commissioner is deemed to have resigned.

# RENTAL ASSISTANCE DEMONSTRATION (RAD) SUMMARY STATUS:

The PCNA Consultant has completed the site assessment and the Phase I Environmental Survey that the Consultant recommended. The Phase II Environmental Survey be done next; however, we are doing another type of investigation.

On December 2, 2019, Chairman Dr. Keith Lafferty sent a letter to May Chuck Lear asking him to assign someone to the informal Housing Authority Ad Hoc Committee to explore Mixed Income and Mixed Finance housing for residents of Cape May. The City of Cape May has appointed Deputy Mayor Patricia Hendricks to this Committee. Chairperson Keith Lafferty will arrange a date for a meeting.

# **ENVIRONMENTAL HISTORY:**

There are two environmental issues:

- 1. Historic Fill responsibility of the Authority to decide what to do. Application for exemption has been filed with the DEP; awaiting a response. The Board will need to make a decision whether or not to remediate the site even if the exemption is granted. If remediation is in order, then the Authority may hire an environmental consultant to help with completing an application for grant money.
- 2. JCP&L issue currently in the hands of the Environmental Consultant (LSRP). The report has been shared with the Board. The Board reviewed the information to determine what course it needs to take with respect to the Deed Notice and requiring JCP&L to perform further remediation of the site(s).

On January 9, 2019 a brainstorming session was held with representatives of the City, CMHA, the Solicitors and the RAD Consultant. It was agreed the LSRP would submit a Proposal for Preparation of Preliminary Cost Estimate to for Osborne Court. Mott MacDonald submitted that proposal on January 16, 2020, to the E.D.

The Board approved a motion for the E.D. to submit that report to JCP&L.

Chairperson Dr. Keith Lafferty for clarification purposes advised the Board that going forward any communications or conversations should be under the umbrella and direction of Attorney Gabage.

### **NON-PROFIT:**

Activities are being planned for the Winter including Valentine's Day and Senior Game Day.

### **UNIT TURNOVER:**

The Board approved a Resolution for the payment of \$8,600.00 for the refurbish of two units with a new Contractor on a trial basis, Broad Street Court 3-4-bedroom units. It was noted that the high cost was due to the amount of damage in one of the units.

The CMHA did not receive any formal bids for the Refurbish of Units Work that was advertised. The E.D. indicated that at this time the CMHA would not rebid work, rather the E.D. would solicit costs from several Contractors for a per diem maintenance worker.

### LAFAYETTE OFFICE REPAIRS:

The Board approved a resolution to award the work to Ocean Construction for a total cost of \$3,972.00.

#### AUDIT:

The Annual Audit was completed on January 10, 2020, a draft report will be submitted soon.

# JIF:

The annual JIF Insurance Invoice in the amount of \$36,171.00 has been received, the Authority will make to semi-annual payments of \$18,085.50.

### **NJ PENSION ANNUAL ASSESSMENT:**

The Annual Pension Assessment in the amount of \$26,609.00 will be paid in April.

### **OSBORNE SECURITY CAMERAS:**

The E.D. received three proposals to provide cameras for this site ranging from \$50.00/month to \$4,000.00. Commissioner Victor Faison suggested the Authority pursue a method of providing the service. Specifically, using a mounted camera that operates via an app such as the ARLO device.

The Board passed a motion for the E.D. to purchase the ARLO camera that utilizes an app for a test period of thirty days; the cost not to exceed \$400.00.

### **SHREDDING:**

The Board approved a resolution to use Shred Pro for the shredding of old CMHA documents.

### T-MOBILE PRESENTATION:

Representatives from T-Mobile presented their Connect Home powered by T-Mobile. In Summary the program provides 8" Android Tablets to residents of Housing Authorities for a minimal monthly cost of approximately \$10.00 per month for the internet service.

The E.D. advised that she will send out a memo to all residents inquiring as to their interests in participating in this Program.

The T-Mobile Representatives left the meeting.
