EPA BRIEFING:

Keith Glenn, EPA Representative, presented a brief summary of information of their operational plan for the Osborne Court Apartment property regarding the assessment that will be conducted:

- EPA will be on site the week of August 3rd.
- On site will be Keith Glenn, Jonathan Byk and 3 contractors.
- Testing will be performed throughout the entire site with approximately 150 samples collected
- Soil collection samples from down to two feet will be sent to two different laboratories
- EPA will be distributing a Community Update to the Board and all of the Tenants on Osborne Court. It will include contact numbers if anyone has any questions.
- EPA will be sampling for lead, other heavy metals and PAH's
- The intent is to determine whether or not there is a problem within the two-foot column since that is the probable level of exposure they are going from.
- EPA will identify where the lead is coming from is from. Historic fill or from a manufacturing process.
- EPA will continue to provide updates to the Board of Commissioners
- EPA timeline –projecting two weeks for the field work then it will take a couple of months for the analysis to come back. That could be a bit longer depending on the backlog at the laboratories.
