SCOPE OF SERVICES

The Housing Authority of the City of Cape May, 639 Lafayette Street will receive bids for Ground Maintenance for the 2018 Season: for Lafayette Court, Osborne Court and Broad Street Court:

Job Specifications:

Lawn Mowing:

Osborne Court, Lafayette Court and Broad Street Court bi-weekly.

Edging Sidewalk:

Lafayette & Osborne courts shall be edged at least once a month during the Season. All cut materials shall be removed, swept or blown after edging.

Ground Area:

Along the fenced area of Broad Street Court and along the fence by the Lafayette Court parking lot to be cut weekly as part of lawn care and all sidewalks blown free of debris.

Spring Clean-Up of Lawn and Beds:

Consists of removing all leaves and debris from the building and lawn. Fertilizer to be applied to all properties, on an as need basis

Edging Shrub Beds:

Prepare beds for mulch and around trees and landscape area in front of Lafayette and Osborne Court area, on an as needed basis.

Mulching of Beds:

Mulch to be supplied by contractor, on an as needed basis

Bed Weed Maintenance:

A pre-emergent weed control to be applied to any area prior to being mulched, on an as needed basis

Pruning of trees and shrubs:

Pruning and shearing of trees and shrubs on all three Courts and debris taken away, on an as needed basis.
